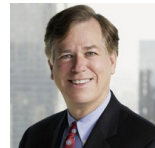

Becoming a Values-Based Leader

HARRY M. KRAEMER, JR., NORTHWESTERN UNIVERSITY'S KELLOGG SCHOOL OF MANAGEMENT

Sometimes doing the right thing while also delivering outstanding and lasting results is difficult for leaders to achieve. Values-based leaders are needed more than ever in today's economic and political environment. Kraemer will address the four principles of values-based leadership. In a dynamic session that draws on Kraemer's global experience as the chairman and chief executive officer of Baxter International, consider the importance of self-reflection, balance, true self-confidence, and genuine humility in the actions and decisions you make as a school leader.



HARRY M. KRAEMER, JR. is an executive partner with Madison Dearborn Partners, a private equity firm based in Chicago, and a clinical professor of management and strategy at Northwestern University's Kellogg School of Management. Kraemer is the author of *From Values to Action: The Four Principles of Values-Based Leadership* and *Becoming The Best: Build a World-Class Organization Through Values-Based Leadership*. He is the former chairman and CEO of Baxter International Inc., a \$12 billion global healthcare company. Educating for Tomorrow's Diverse Democracy Today

With public trust in many institutions at record lows and polarization driving us further apart, it's essential for schools to build communities that encourage civil discourse, dialogue, and the ability to see the world through another's eyes. Costello will address how heads can lead in this area through curriculum development, professional learning for faculty, and nurturing an inclusive school culture.



MAUREEN COSTELLO leads the Southern Poverty Law Center's (SPLC) Teaching Tolerance project, a provider of anti-bias education resources. She oversees the *Teaching Tolerance* magazine, the development of teaching kits, and professional development resources. Before joining the SPLC, she oversaw development of the 2010 Census in Schools program for Scholastic Inc. Costello served as academic dean at Notre Dame Academy High School in NY. She is a graduate of the New School University and the New York University Graduate School of Arts & Sciences.

Leveraging the Independence of Our Schools

Although we face many challenges as a community—declining enrollments, challenging parental attitudes, a highly-charged political scene, etc.—independent schools have a unique opportunity to leverage their independence to address these challenges and provide leadership to students, families, and society. Orem will discuss current and emerging issues and how school leaders can face them through a lens of opportunity, as well as outline tools and strategies leaders can implement to create a more sustainable future.



DONNA OREM was named president of the National Association of Independent Schools (NAIS) in November 2016 after serving as interim president since November 2015. Orem served as the chief operating officer for NAIS for 11 years before becoming president. She joined NAIS in 1998 as the vice president for educational leadership, later becoming the vice president for strategic initiatives and research. Prior to NAIS, she worked at the Council for Advancement and Support of Education and The American Association of University Women. Orem is the co-author of the *NAIS Trustee Handbook*, 10th edition, and is the author of numerous books and articles. She holds a BA from St. Joseph's University (PA) and attended graduate school at the University of Maryland School of Journalism.

Alternative Models of Assessment, Crediting & Transcripts *

How can a GPA or an ACT score tell the story of a student? The Mastery Transcript Consortium (MTC) is a collective of independent schools organized around the development and dissemination of an alternative model of assessment, crediting, and transcript generation. This session will share how the consortium hopes to change the relationship between preparation for college and college admissions for the betterment of students. Participants will explore how the MTC model differs—organized around performance areas, mastery standards, and micro-credits—from the traditional transcript and learn how this electronic model allows college admission officers to see actual evidence of student work and mastery.

Prevention of & Response to Sexual Misconduct: Recommendations from the Task Force

In 2016, The Association of Boarding Schools (TABS) and the National Association of Independent Schools (NAIS) convened a task force to take a 360° look at educator sexual misconduct in independent schools and develop recommendations to help schools prevent misconduct and respond justly, compassionately, and effectively to cases of misconduct, past and present. In this session, we will present the major task force recommendations, outline resources TABS and NAIS are developing to assist schools in implementing these recommendations, and engage you in discussion on how best to proceed at your school.

Managing Bias to Hire the Best Talent

We are committed to fair, equitable, and inclusive processes. Yet the hiring process is an area where our organizational and personal biases can get in the way of making the best decisions. Participants will understand the value and power of a diverse and inclusive workforce; learn how bias gets in the way of achieving diverse representation; understand unconscious bias, how it shows up and how it works; and be introduced to strategies that help us all manage bias to assess talent appropriately.

Radical Empathy

"We don't see each other," the NYPD commissioner said. We don't hear each other often either. Not deeply. We say we want diversity of thought—yet when discussing difficult topics or our human differences, our inclination can be to polarize—to choose sides, to minimize others, to see the world from our limited lens. We do want to connect with others across differences and navigate difficult situations, tough topics, and conflict with skill and care. What makes being empathetic radical? Our willingness and ability to have respectful and real conversations even given deep convictions, values, and differences. This interactive session will address the mindsets and skills we need to see and hear each other. We'll focus on strengthening our empathy skills and discuss creative ways to use these skills to explore different perspectives.
